fortune so long to live the said Elizabeth and my sone as he shall fortune to
have shall after keepinge and bringinge upp my said sone Andrew at the charges
of sufficient meate drinke and clothinge to the good contentment and likinge of
Andrew Bateson my brother and Roger Cowpe also Gulpan my brother in law or the
survivors of them utterly to dislike w^{ch} the said Elizabeth or my said sone shall
bringinge upp keepinge clothinge and education of the said Andrew Bateson my
sone that from the foresaid bequest gift and devise unto her the said Elizabeth of my
foresaid lands tenements and other the premises shall stand and be utterly frustrated
void to all intents and purposes from my will is that the said Elizabeth shall in life and
maine duringe the life of Anne my wife and lawfully bring upp my daughter
Elizabeth Bateson w^{ch} sufficient meate drinke and apparell under the life condition
that if it fortune the said Andrew Bateson my said brother and the said Roger
Cowpe also Gulpan or the survivors of them to mislike w^{ch} the government and bringinge
upp of my said daughter that then the foresaid gift and bequest made to the said
Elizabeth shall in the maine cease and be utterly void and I will that the said
Andrew Bateson my said brother and the said Roger Cowpe also Gulpan shall from hence
forth have the entire keepinge and bringinge upp of my said sone Andrew till
he shall accomplish his full age of xxth years if so he shall live and also the tuition
of my said daughter and for and towards the maintenance of my said children &c.
accordingly I give and bequeath assigne devise unto them the said Andrew
Bateson my brother and the said Roger all and singular tenements closes pastures
meadowes and grounds hereafter named next of the premises before by these presents
devise bequeath and assigned unto the said Elizabeth that is to say the close called
Ranfist the wood first the signe of the Swan the house and the house to be kept from the

Andrew or Elizabeth my children until the full age of the said Andrew my sone
xxth years if so he shall live so long from my wife Denise shall assigne unto my said
daughter Elizabeth the summe of five hundred pounds of lawful english money to be
performed in mariage to be payinge & goinge out as well of all and singular the

in the present to be devised by the said Roger Gonye last will and testament
contented in the said will and testament of the said Roger Gonye and the said Sabella
shall be my daughter for ever to be paid on and behalf of the fore said Roger Gonye
or assigns of the said Roger Gonye or bequeathed as is aforesaid the said payments to be
made in the part of the said Roger Gonye or assigns of the said Roger Gonye
accordingly then I will that my said daughter Sabella and her heirs shall have all the said
lands, tenements, hereditaments that the said Andrew Watson my begetter for ever to dye living

in his my last will and testament only touching and concerning me and some of

lived full age and he utterly void and of no effect and from henceforth I will give
